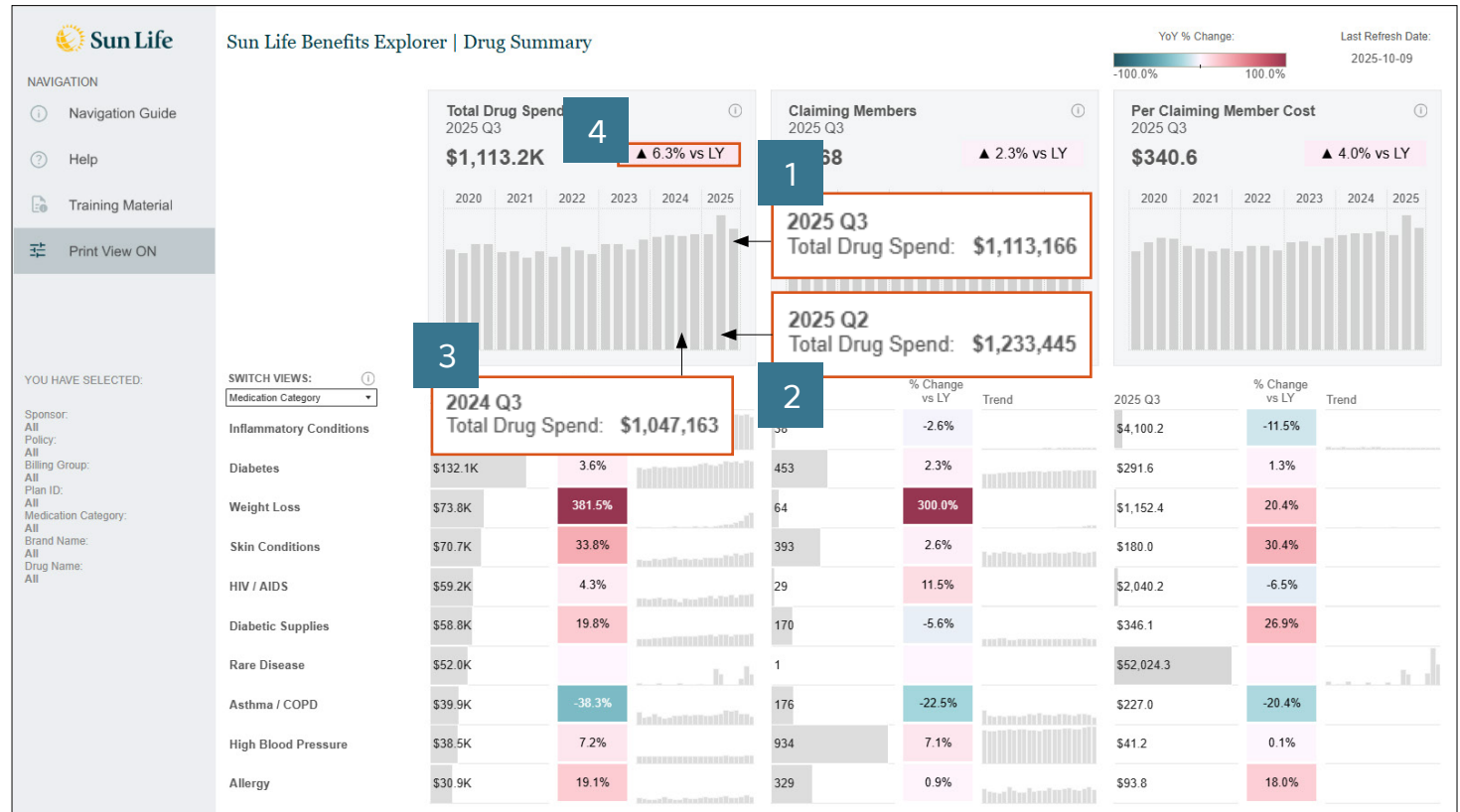

# Sample Use Case 1 – Example to calculate the percentage change from this quarter to the same quarter last year

To see the Total Plan Member Drug Spend for each quarter, hover over the grey bars shown in the screenshot below:

- 1 2025 Q3 Total Drug Spend: \$1,113,166
- 2 2025 Q2 Total Drug Spend: \$1,233,445
- 3 2024 Q3 Total Drug Spend: \$1,047,163
- 4 In this example, the % vs LY metric calculates the percentage change comparing 2025 Q3 vs 2024 Q3. This shows an increase of 6.3%

To calculate the percentage change from this quarter to last quarter, i.e., 2025 Q3 vs 2025 Q2, you need to manually calculate the percentage change using 2025 Q3 Total Drug Spend and 2025 Q2 Total Drug Spend. This would be a decrease of **9.8%**, calculated by  $((\$1,113,166 / \$1,233,445) - 1) * 100$

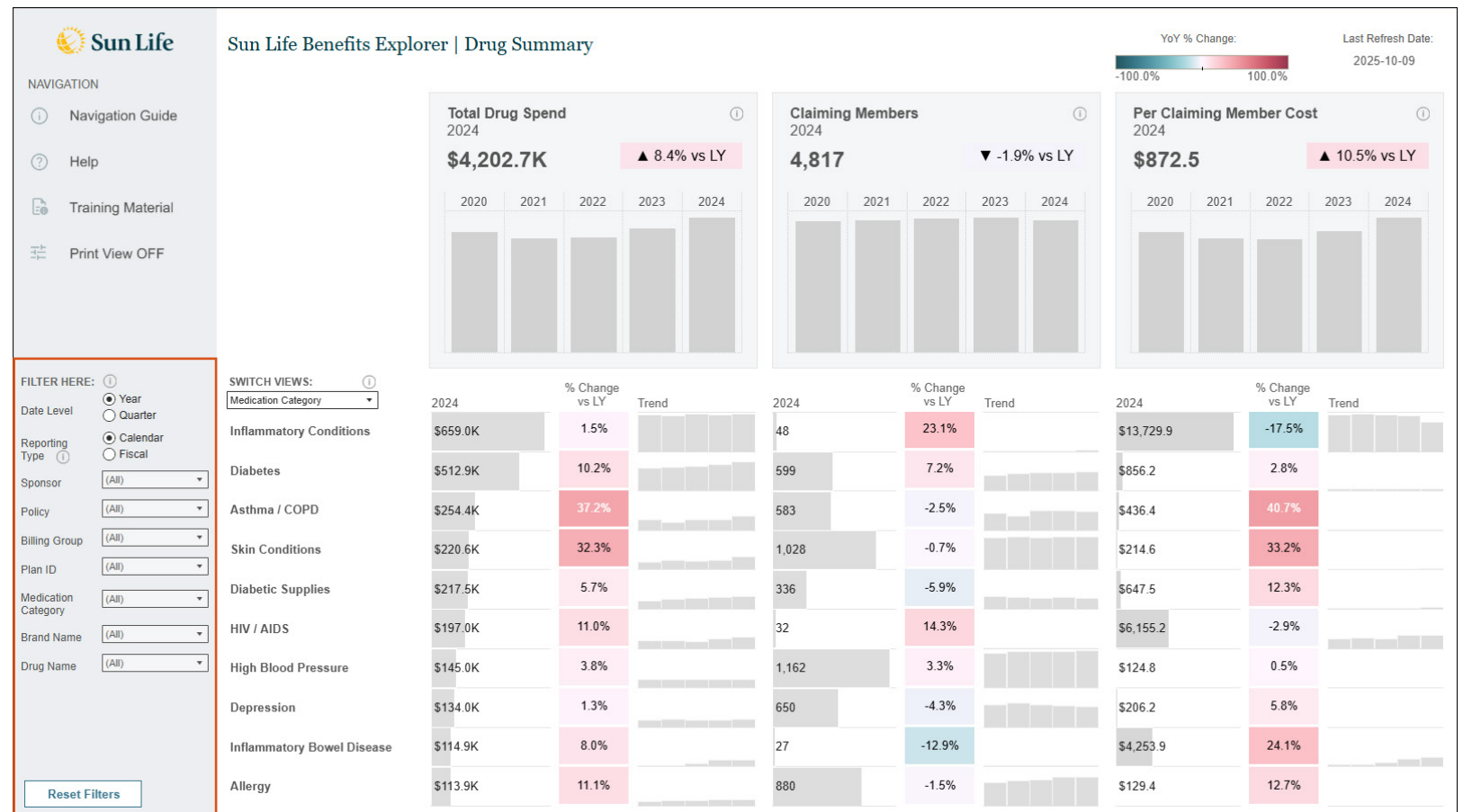

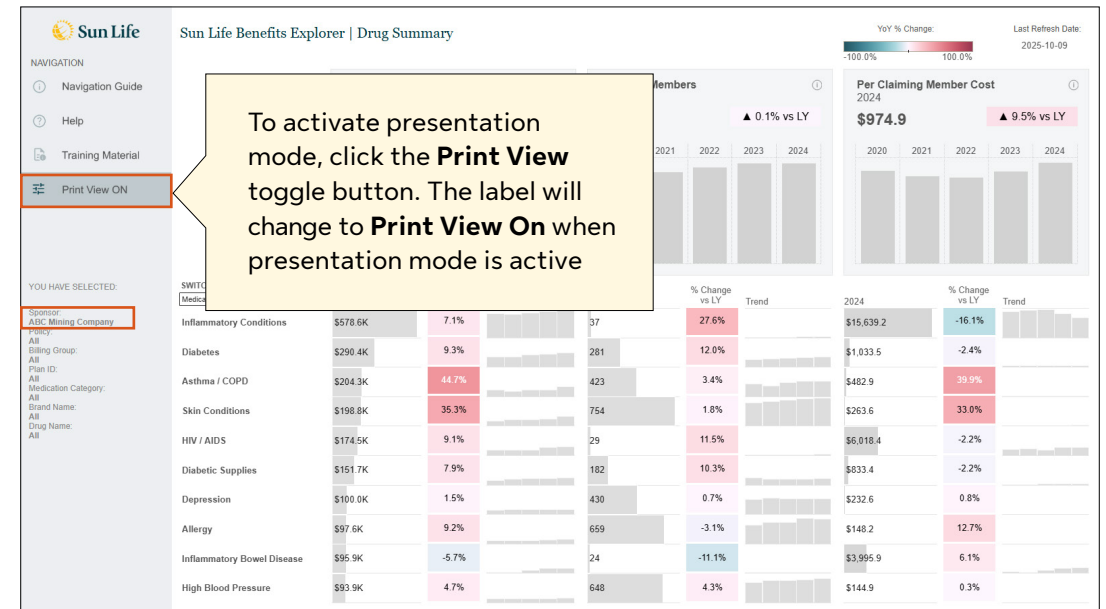
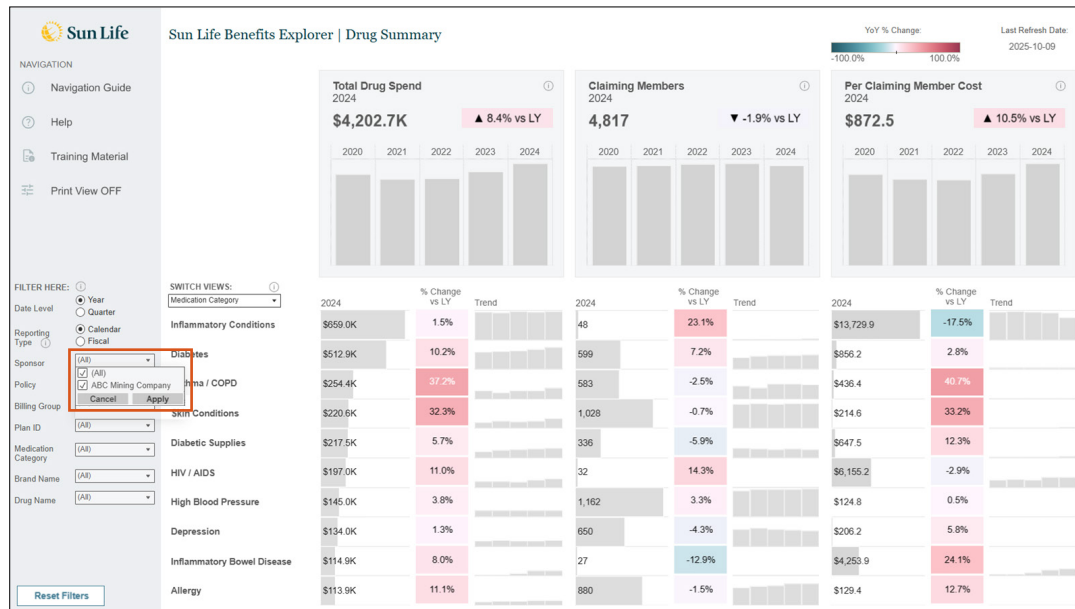
# Sample Use Case 2 – Use filters to customize dashboards

**Sponsors**, customizing dashboards allows you to access information for your organization, or view data at a more detailed level.

## How can I view information for my organization (ABC Mining Company)?

When you first open the dashboard, it displays information for your organization. To make sure this is for your organization, ensure no filters are applied.

Your organization will already be selected in the sponsor filter and that is the only organization you will see.



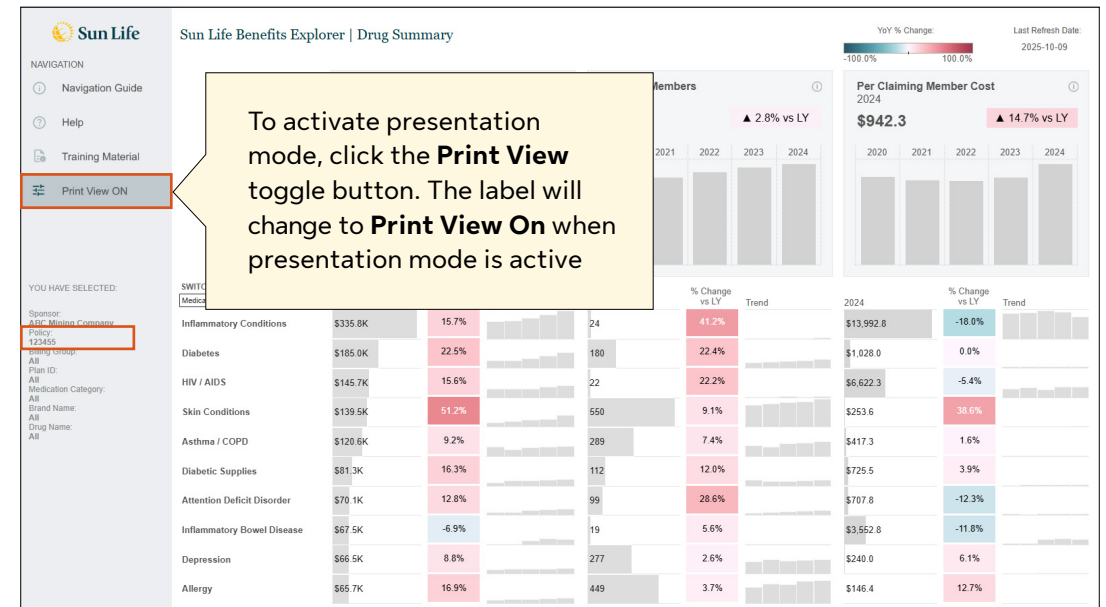
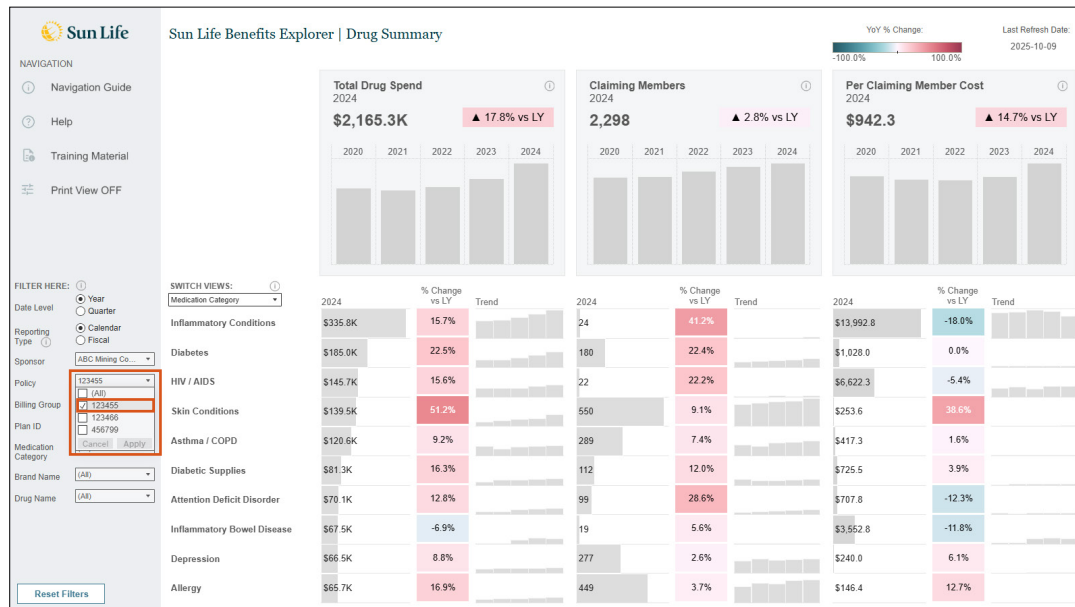
# Sample Use Case 2 – Use filters to customize dashboards

## How can I view information for specific policies within my organization (ABC Mining Company)?

### To view one policy (123455):

- In the Filter section, click on the drop-down beside the Policy filter.
- Click on All to deselect all policies.
- Choose '123455'. Click on Apply.

If you have a long list of policies you can use the search bar in the drop down list to type in the policy of interest.



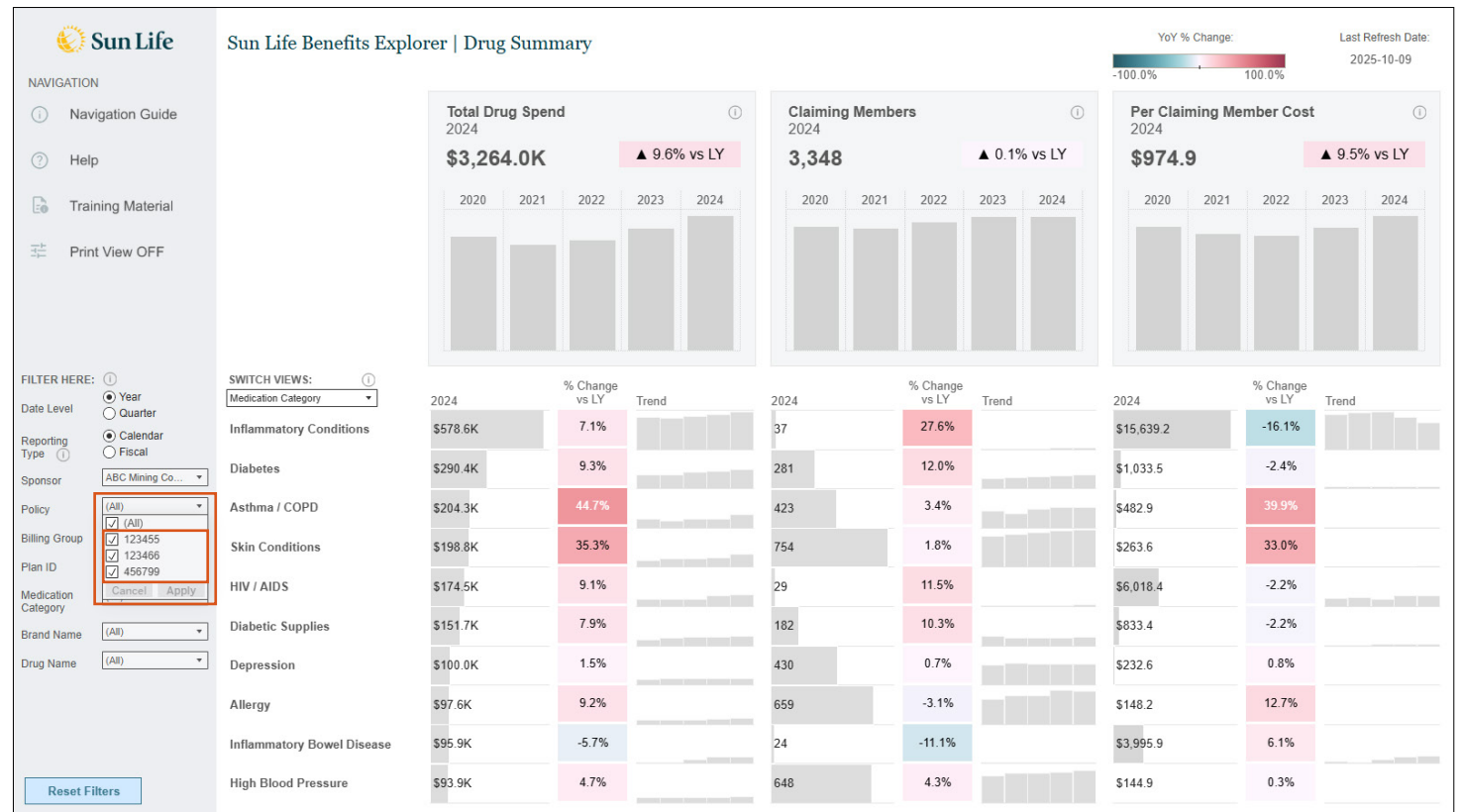

You can choose Diabetes in the Medication Category and switch the view to 'Drug Name' to understand which drugs are driving that Medication Category in the previous quarter and their growth. To do this:

- 3.1 In the Filter section, choose Diabetes in the Medication Category



You can use 'switch views' on the main page to investigate the reasons for the Diabetes cost increase by focusing on top Brand Names or top Drug Names.

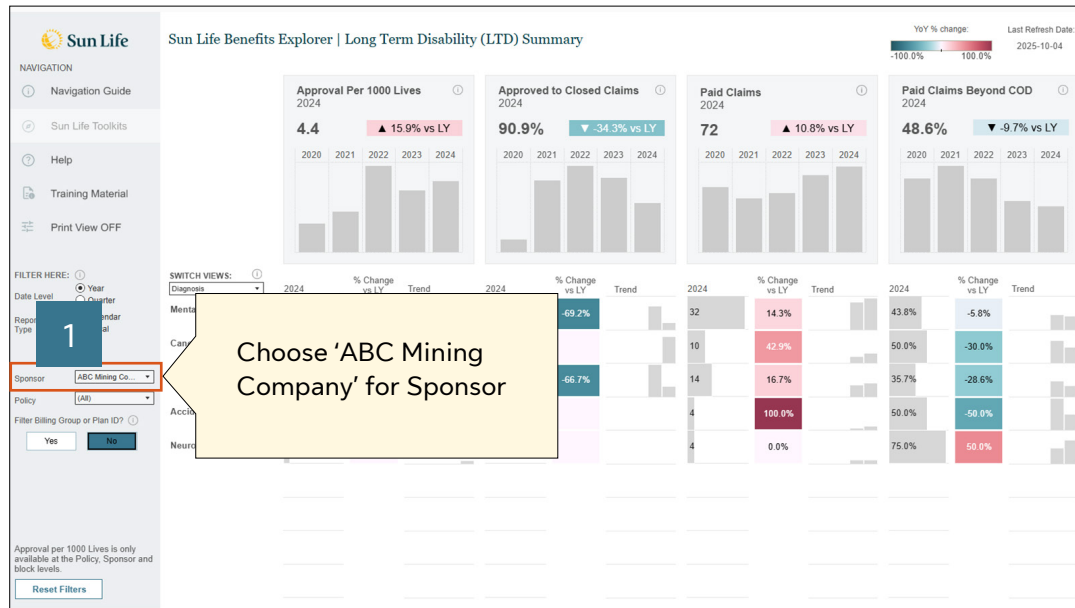

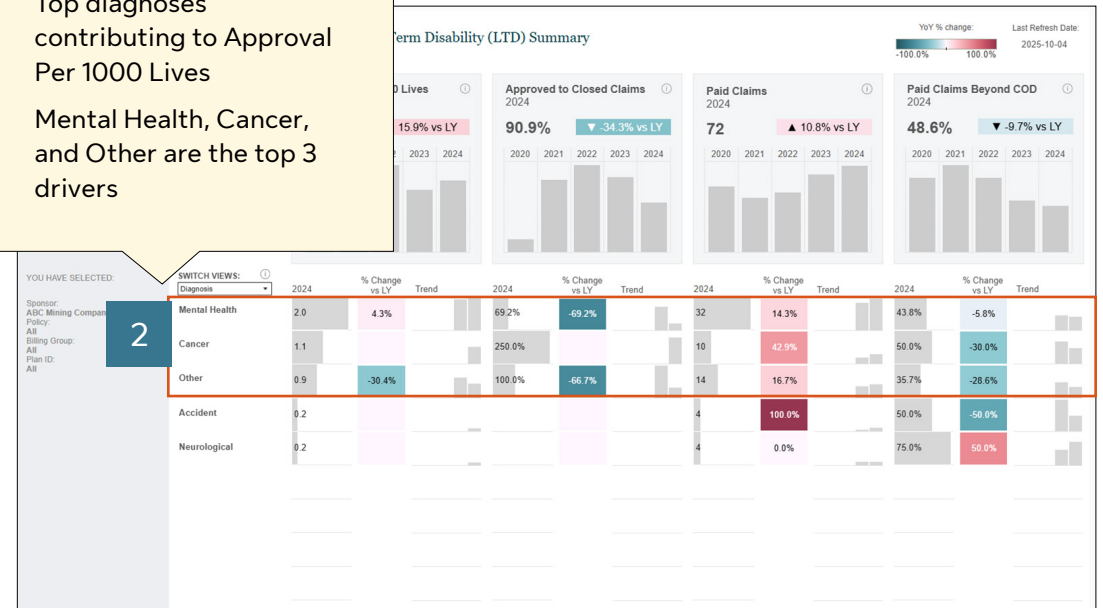

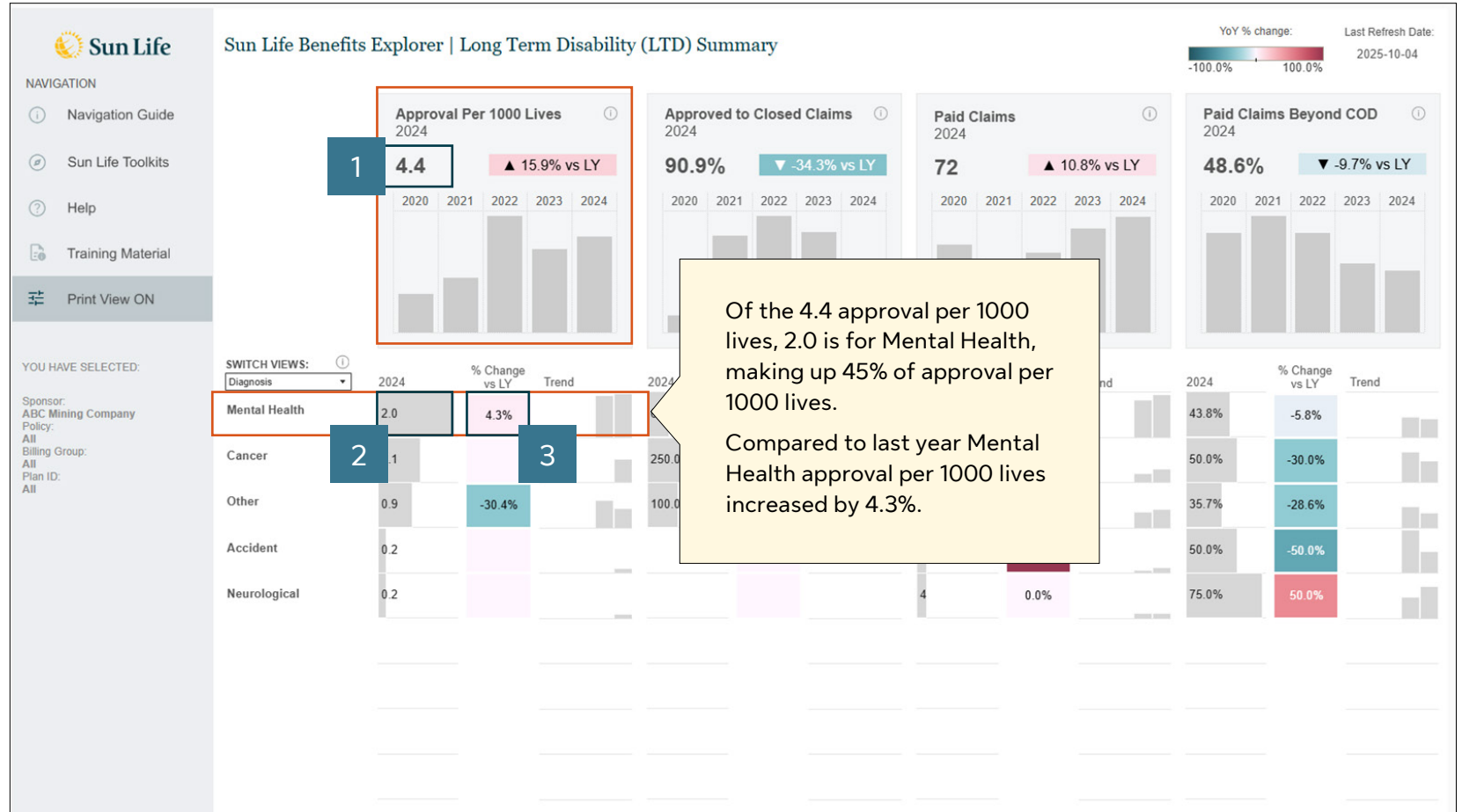
## What is the impact of Mental Health on the Approval per 1000 Lives metric?

You can find the information for Approval per 1000 Lives below:

- 1 Value in the most recent complete year, overall (not split by Diagnosis)
- 2 Value in the most recent complete year for Mental Health (split by Diagnosis)
- 3 Percentage change from this year compared to last year for Mental Health

Of the 4.4 approval per 1000 lives (1), 2.0 is for Mental Health (2), making up 45% of approval per 1000 lives. Compared to last year Mental Health approval per 1000 lives increased by 4.3% (3).

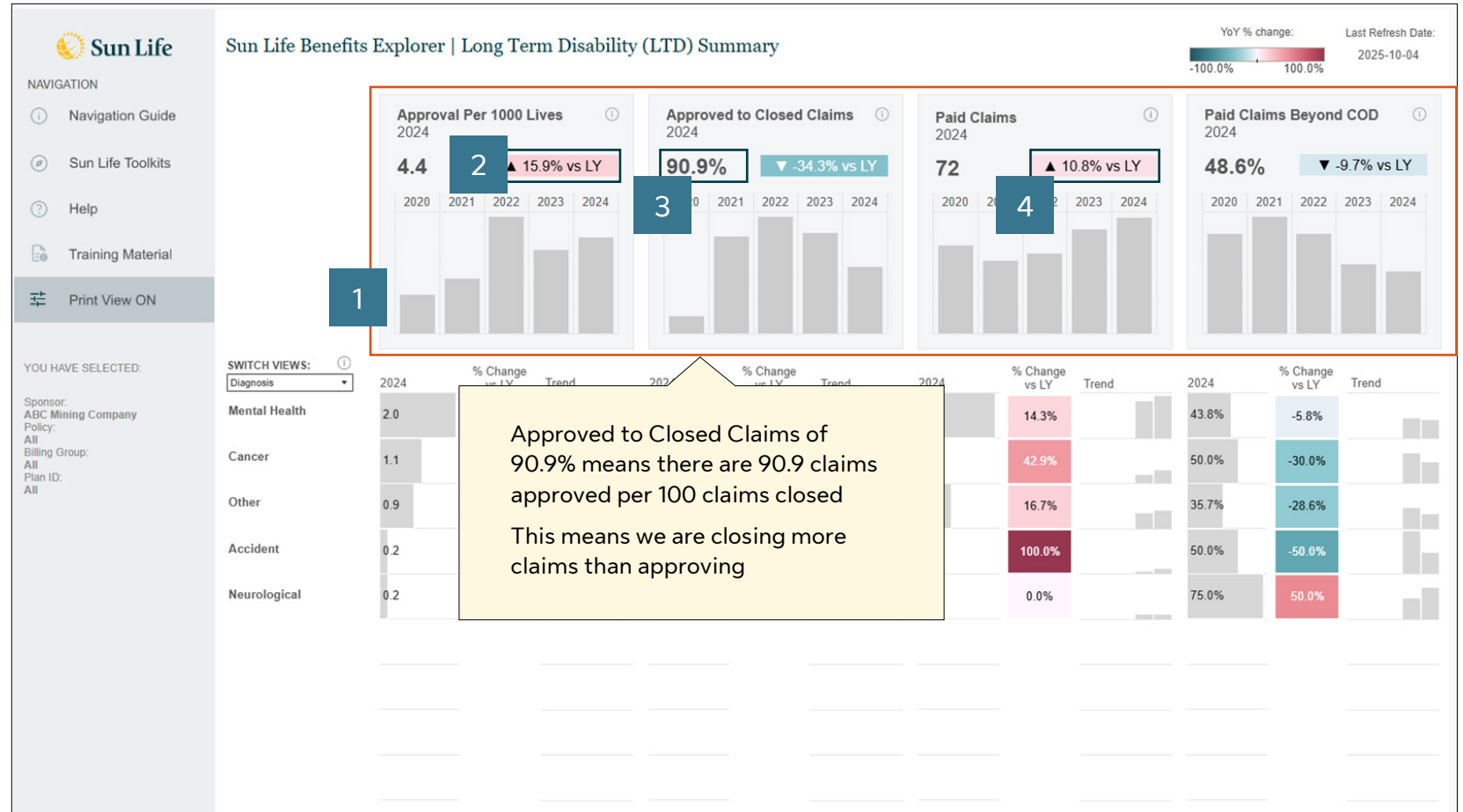
# Sample Use Case 8 – LTD summary

## How does ABC Mining Company's metric of approved to closed claims contribute to paid claims?

- 1 To view metrics at the overall/block level, i.e., not split by Diagnosis, focus on the top section
- 2 Approval per 1000 lives comparing this year to last year
- 3 Ratio of approved claims to closed claims
- 4 Paid claims comparing this year to last year

While approval per 1000 lives increased (2), approved to closed claims is below 100% (3), meaning that closed claims exceeded the approved claims. Despite this, the increase in approval per 1000 lives still contributed to an overall rise in paid claims (4).
